## **Terms and Conditions**

### **EAIM Overseas Merit Scholarship Award**

1. Application for the EAIM Overseas Merit Scholarship is open to all students who will be pursuing a full-time course of study at the Institute. Application must be submitted to EAIM prior to course commencement. Late applications will not be entertained unless there is prior arrangement with EAIM.
2. Applicants must submit the appropriate Scholarship Application Form duly completed, with relevant supporting documents. Any incomplete or wrong information shall render the application null and void.
3. Applicants must demonstrate good academic results and are expected to have satisfied the academic requirement for scholarship. Besides academic inclination, all scholarship holders must demonstrate exemplary conduct at all times.
4. **In the event that student decides to discontinue with the scholarship before the completion of programme, student will have to repay the expended portion of the full tuition fee and to settle all outstanding payment with the institute immediately.**
5. **The scholarship holders must obtain all As in all the modules during the first semesters' assessments & examinations.** Failure to obtain all **As** will result in exiting the scholarship award and the scholarship holders that exit the award will have to make prorated tuition fees payable to EAIM (prorated tuition fees only for second semester). Those scholarship holders that maintained all **As** in the first semesters' assessments / examinations will continue to enjoy the scholarship award benefits.
6. All award holders are expected to participate in events organization by EAIM. EAIM will have a variety of functions throughout the year. It could be welcoming a famous ambassador, helping to organize events or being the face of EAIM and so on. Whatever task/tasks that given to award holders, he/she will be required to participate actively and with full commitment.
7. All award holders are expected to conduct themselves exemplarily and in an ethical manner so as to uphold and enhance the good name and reputation of EAIM. He/she must serve as a role-model to the other students. Any misbehavior in public or at school, including unsatisfactory or poor conduct and attendance below 90%, will result in the withdrawal of the award.
8. Payment of the course fees after being awarded the Scholarship or study grants before enrolment, will need to be made according to the payment schedule indicated in the student contract
9. The award holders are also required to abide by the prevailing rules and regulations of EAIM and the authorities of Singapore.
10. The Institute shall have the right to seek verification of all information & documents provided for the purpose of application processing and evaluation. All documents submitted as part of the application process shall remain the property of EAIM.
11. The Institute has the right to make such information available to relevant and authorized government agencies and regulatory authorities.
12. All awards are subject to periodic (quarterly, bi-annual or annual) reviews of the academic performance, attendance, and conduct of the award holders.
13. Award holders who fail to comply with all the prevailing terms and conditions of the Award, will have their Scholarship Awards withdrawn.
14. All award holders will sign the Standard Student-PEI contract and accept the terms and conditions therein.
15. EAIM respect the protection of personal data and strives to protect the security of your information. In signing this application form, the applicants have given consent that the information gathered may be used for the processing and evaluation of his/her application by EAIM. The applicants also understand and agree that if he/she been awarded with the Scholarship, any personal information that he/she may provide to EAIM at any point of time during the course of the study whether through manual or digital channels will be used for the provision of student support and administrative services to them.
